INSTRUCTIONS FOR NET QUALIFIED CANDIDATES-JUNE 2015

- 1. The Supervisor/Guide/Fellowship awarding Authority/Lectureship appointing Authority Viz. University/Instt. must verify the original record/certificates of the candidate regarding eligibility criterion & caste/PH/VH certificate (if applicable) for this test while considering him/her for fellowship/appointment, as CSIR is not responsible for the same.
 - 2. Extract of Eligibility Criterion as laid down in the Notification No.10-2-(5)/2015(i)-E.U.II published in Employment News dated 14th – 20th Feb, 2015 for this examination:
 - (a) EDUCATION QUALIFICATION: BS-4 years program/BE/BTech/BPharma/MBBS/ Integrated BS-MS/M.Sc or equivalent degree with at least 55% marks for General and OBC; 50% for SC/ST candidates, Physically and Visually Handicapped candidates.

The eligibility for Lectureship of NET qualified candidates will be subject to fulfilling the criteria laid down by UGC. Ph.D degree holders who have passed Master's degree prior to 19th September 1991, with atleast 50% marks are eligible for lectureship only.

The education qualification criteria as notified by CSIR in the Employment News/CSIR HRDG website (www.csirhrdg.res.in).

(b) AGE LIMIT & RELAXATION:

- (i) JRF(NET): Maximum age limit is 28 years as on 01.01.2015 (relaxation in upper age up to 5 years for candidates belonging to SC/ST/OBC-Non Creamy Layer-Central List/PH/VH/Female candidates).
- (ii) <u>LECTURESHIP (NET)</u>: No upper age limit for Eligibility for Lectureship category.
 - 3. SC/ST/OBC/PH/VH certificates should be as per CSIR notification (Para 5.3).
